

## Fundraising Requirements

1. GA Representations. GA hereby represents to Licensee that, as of the Effective Date (i) GA is an authorized reseller of VeriSign payment processing services, (ii) GA is required, pursuant to the terms of its reseller agreement with VeriSign dated March 10, 2004, to include in its Agreement with Licensee the pass-through terms provided in Sections 2 through 10 below, and (iii) VeriSign has represented and warranted to GA that VeriSign will honor its obligations to Licensee under this Agreement.
2. Processing Online Financial Transactions. Licensee shall be solely responsible for establishing and maintaining a commercial banking relationship with a Financial Institution. The terms of such relationship shall be determined solely by Licensee and its Financial Institution. Licensee shall comply with all applicable rules of the credit card associations Licensee opts to honor on Fundraising or Events Module pages.
3. Authorization for GA to Provide Data. Licensee authorizes GA to provide VeriSign with the Member-Level Data required to complete Transactions. VeriSign warrants that it shall not disclose such data to third-parties or use the data, except as necessary to provide the VeriSign Services. VeriSign will maintain such data only as long as necessary, or as required by law and used internally for record keeping, internal reporting, and support purposes. VeriSign may disclose the data as required by law or court order.
4. Licensee Responsibilities. Licensee represents and warrants that Licensee shall comply with all privacy, consumer protection, charitable solicitation, reporting and other laws and regulations applicable to its use of the Fundraising or Events Modules. Licensee is solely responsible for any registrations required to solicit funds and for complying with any reporting required by governmental entities. Licensee shall be solely responsible for maintaining commercially reasonable business practices in conjunction with its financial transactions and ensuring the security and privacy of its members' data. Licensee shall comply with VeriSign requests for reasonable action on Licensee's part, to the extent necessary, to maintain the security and integrity of VeriSign's services.
5. Should Licensee be granted access to the VeriSign administrative dashboard by GA:
  - 5.1 Licensee shall be responsible for keeping its VeriSign names and passwords confidential. Licensee shall notify VeriSign and GA immediately upon learning of any unauthorized use of its name or password. Licensee shall be responsible for reviewing the transactions in its account on a regular basis and for promptly notifying VeriSign and GA of suspected unauthorized activity through its account. If Licensee desires to change its VeriSign password, Licensee must provide GA with prior email notification in order to ensure service configurations are correctly updated.
  - 5.2 VeriSign will provide Licensee with access to standardized reports regarding Licensee's transactions processed by VeriSign and certain reporting tools to assist Licensee in accounting activities. VeriSign hereby grants Licensee the right to access and use the VeriSign Service in accordance with these terms.
6. Sale of Products or Services. Licensee shall be solely responsible for fulfilling all orders for products or services offered as a component of financial transactions, and for proper payment of all taxes which may be levied on sales of its products or services. Licensee shall bear all collection risk (including, without limitation, credit card fraud and any other type of fraud) with respect to sale of its products or services.
7. Termination of Financial Transaction Services. VeriSign may suspend the processing of online financial transactions for Licensee (i) following ten (10) days prior electronic or written notice if Licensee is violating applicable law, perpetrating fraud or causing (or failing to fix) a security breach relating to its services, failing to respond to an inquiry from VeriSign concerning the accuracy or completeness of the information Licensee is required to provide pursuant to this

Agreement or if VeriSign reasonably suspects fraudulent activity on Licensee's payment services account; and (ii) on one (1) day's written or electronic notice if VeriSign reasonably believes Licensee is sending data that corrupts or jeopardizes VeriSign's computer systems or Licensee's financial processor or financial institution with which Licensee has a merchant account requires such suspension.

8. VeriSign Indemnification. Licensee will indemnify, defend and hold harmless VeriSign, its officers, directors, agents and employees, from and against any and all claims, losses, demands, liabilities, damages, costs and expenses (including reasonable attorneys' fees), either arising out of or relating to (i) the breach of any representation or warranty by Licensee, (ii) the sale or use of any product or services sold by Licensee, (iii) claims brought or damages suffered by any financial institution, member, or prospective member of Licensee relating to Licensee's or its agents' misuse of VeriSign Services or (iv) the breach of these VeriSign pass-through terms by Licensee.
9. VeriSign Warranty Disclaimer. VERISIGN MAKES NO WARRANTY OF ANY KIND, EXPRESS, IMPLIED OR STATUTORY, REGARDING THE VERISIGN SERVICES PROVIDED PURSUANT TO THESE TERMS, AND ALL SUCH WARRANTIES, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR PARTICULAR PURPOSE AND NON-INFRINGEMENT ARE HEREBY EXPRESSLY DISCLAIMED BY VERISIGN. LICENSEE ACKNOWLEDGES THAT VERISIGN HAS NOT REPRESENTED OR WARRANTED THAT THE VERISIGN SERVICES WILL BE UNINTERRUPTED, ERROR FREE OR WITHOUT DELAY.
10. VeriSign Limitation of Liability. Licensee acknowledges that VeriSign is not a financial or credit reporting institution. VeriSign is responsible only for providing data transmission to effect certain payment authorizations for Licensee and is not responsible for the results of any credit inquiry, the operation of web sites of GA or financial institutions or the availability or performance of the Internet, or for any damages or costs Licensee suffers or incurs as a result of any instructions given, actions taken or omissions made by Licensee, Licensee's financial processor(s), Licensee's financial institution or any Internet Service Provider. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT WILL VERISIGN HAVE ANY LIABILITY TO LICENSEE OR ANY OTHER THIRD PARTY FOR ANY LOST OPPORTUNITY OR PROFITS, INJURY TO ANY CUSTOMER RELATIONSHIP, COSTS OF PROCUREMENT OF SUBSTITUTE GOODS OR SERVICES, OR FOR ANY INDIRECT, INCIDENTAL, CONSEQUENTIAL, PUNITIVE OR SPECIAL DAMAGES ARISING OUT OF THE TERMS, UNDER ANY CAUSE OF ACTION OR THEORY OF LIABILITY (INCLUDING NEGLIGENCE), AND WHETHER VERISIGN HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGE. IN ANY CASE, VERISIGN'S ENTIRE LIABILITY UNDER ANY PROVISION OF THE TERMS SHALL NOT EXCEED IN THE AGGREGATE THE TOTAL OF THE FEES PAID TO VERISIGN ON BEHALF OF LICENSEE FOR THE SERVICES. THESE LIMITATIONS WILL APPLY NOTWITHSTANDING ANY FAILURE OF ESSENTIAL PURPOSE OF ANY LIMITED REMEDY.
